Bruseker.</p> <p>(2) The Select Special Committee consider</p> <p style="padding-left: 40px;">(a) the appropriateness of the provisions of the Electoral Boundaries Commission Act; (b) the implications of the Charter of Rights and Freedoms for electoral boundaries and the distribution of constituencies; (c) the composition of the Commission and the process by which it is to carry out its responsibilities; (d) any legislation, legal decisions, and historic and current practices of Alberta or other Canadian jurisdictions relating to the distribution of constituencies and their boundaries; (e) any geographic, demographic, and other factors that should be considered in the distribution of constituencies and the determination of their boundaries; (f) the impact of the determination of constituency boundaries on the ability of Members of the Legislative Assembly to fully discharge their duties to their constituents; (g) any other factors that the Committee reasonably considers relevant in the discharge of its duties.</p> <p>(3) The Select Special Committee may hold public hearings in Alberta.</p> <p>(4) The Select Special Committee is authorized to travel within and outside Alberta.</p> <p>(5) Reasonable disbursements by the Committee for staff assistance, equipment and supplies, public information needs, rent, travel, and other expenditures necessary for the effective conduct of its responsibilities shall be paid, subject to the approval of the Chairman.</p> <p>(6) In carrying out its responsibilities, the Committee, with the approval of the Chairman, is authorized, with the concurrence of the head of the department, to use the services of members of the public service employed in that department or of the staff employed by the Assembly.</p> <p>(7) The Select Special Committee shall report and make recommendations to the Assembly during the First Sitting of the Second Session the 22 Legislature of the Province of Alberta.</p>	Hon.
