## Bill 10

## Appropriation (Supplementary Supply) Act, 1996

THE CHAIRMAN: The hon. Member for Edmonton-Whitemud.

DR. PERCY: Thank you, Mr. Chairman. I rise to speak in committee to the supplementary estimates and in particular to the supplementary estimates of the Department of Environmental Protection. The expenditure of \$3.211 million we find offensive on this side of the House. After a half-billion dollars, Mr. Chairman, being spent on Swan Hills . . .

MRS. SOETAERT: How much? How much?

DR. PERCY: A half-billion dollars, with mistake after mistake in terms of the process of administration of the plant, in terms of the incentives that have been set in. This is the final indignity after a cut of a thousand deaths or a half-billion. It's expensive. We view this as vexatious. We would certainly like to see the sum eliminated, save for \$1, from the supplementary estimates. To that end, we have an amendment that I would like to speak to. The amendment has been signed by counsel and is presently being distributed.

Mr. Chairman, what's the point of this exercise? A half-billion taxpayer dollars, yet the government has no shame in this. They come back for yet another \$3.2 million. We, in fact, pay for the delay in terms of putting in an agreement that caps the hemorrhaging under the joint venture agreement. We were not able to do anything in this Legislature about the joint venture agreement. That was signed. We had to live with the consequences. It was not reviewed by the environment minister, now Premier. It was signed, in fact, by the environment minister, now Premier. Every opportunity that could have been employed to assess the constraints imposed by the joint venture agreement was missed. The opportunities to abrogate the agreement were foregone, and the Auditor General was very clear in his criticisms of the role the government played in that agreement. So on principle we view these funds as not being appropriate.

The amendment, Mr. Chairman, calls for the striking out of that sum of \$3.2 million and substituting the sum of \$1, which we think is more than sufficient, given the half-billion that will have gone down the tubes, or up in smoke in this particular endeavour.

THE CHAIRMAN: The Chair would observe that the requisite signatures are affixed and would call upon the hon. Member for Fort McMurray on the amendment.

MR. GERMAIN: Thank you very much, Mr. Chairman. It is hard for me to do justice to this particular amendment after the excellence of the presentation from the hon. Member for Edmonton-Whitemud. It's trite to point out that when we are in the last month of the budget year, there is a heavy onus on ministers who present expenditure items in their portfolio that ask the taxpayers of this province to dig even deeper into their pockets. When you measure this particular expenditure, the Bovar fiasco, where Albertans have allowed their pockets to be picked time and time again - and this Legislative Assembly has now voted three times on expenditures to bail out this particular aspect - it seems to me that what we are doing is simply opening our pockets wide to be picked. The way you stop and discourage a pickpocket, ladies and gentlemen, is you close your pockets. That's what you do. Tonight I urge all members to have the courage, to have the courage, to close your pockets.

THE CHAIRMAN: Are you ready for the question? We have an amendment known as A1 proposed by the hon. Member for Edmonton-Whitemud. All those in support of the amendment, please say aye.

SOME HON. MEMBERS: Aye.

THE CHAIRMAN: Those opposed, please say no.

SOME HON. MEMBERS: No.

THE CHAIRMAN: Defeated. Call in the members. Two minutes.
