Be it resolved that the Legislative Assembly urge the Government to provide additional resources to schools to cover the costs of textbooks, software, technology, learning materials, and teacher training that are required because of the introduction of a new curriculum mandated by the Government.

#### **3. 516.** Ms Carlson to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to continue a reconfigured Special Places program until it is complete and to establish a panel of independent scientific experts to advise the Government on what areas need further protection to conserve the biodiversity of all ecoregions in the province.

#### **4. 517.** Mr. Sapers to propose the following motion:

Be it resolved that the Legislative Assembly establish an all-party Select Committee of the Legislative Assembly on the Future of the Alberta Treasury Branches to seek the input of Albertans through public hearings.

Be it resolved that the Legislative Assembly urge the Government to make more bursaries and student loans available for students who have to relocate to one of Alberta's major urban centres to attend post-secondary school.

Be it resolved that the Legislative Assembly urge the Government to refer all provincial user fees, licences, and premiums to the Standing Committee on Law and Regulations for review.

Be it resolved that the Legislative Assembly urge the Government to implement strategies aimed at increasing the opportunity for Alberta students to participate in student exchange programs, particularly with respect to learning new languages, and to initiate new international student exchange partnerships.

Be it resolved that the Legislative Assembly urge the Government to engage in public consultation about an alternative funding model for public education.

## **9. 522.** Ms Leibovici to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to increase funding for long term care to provide better access and to ensure that individuals are able to remain in their home communities when they require long term care.

#### **10. 523.** Mr. Yankowsky to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to encourage motorists to practice safe driving by not using hand held cellular phones while operating a vehicle.

## 11. 524. Dr. Pannu to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to introduce legislation which requires employers to provide pro-rated benefits to part-time and casual workers that are equivalent to those provided to full-time workers; extends the scope of employment standards, health and safety, and workers' compensation legislation to farms and ranches employing three or more workers; imposes mandatory penalties on employers who repeatedly violate employment standards; enables the Labour Relations Board to impose first collective agreements; bans the use of replacement workers during a legal strike or lockout; restores full collective bargaining rights, including the right to strike, to nurses, civil servants and other public sector workers providing non-emergency services.

Be it resolved that the Legislative Assembly urge the Government to conduct an independent review of student costs incurred in accessing post-secondary education programs.

Be it resolved that the Legislative Assembly urge the Government to make it a requirement that Alberta's public schools provide for the singing of our National Anthem once per day.

## **15. 528.** Mr. White to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to consider getting out of the business of direct loans and guarantees to the private sector through the wind-down of the Alberta Opportunity Company, with no new loans and guarantees to be authorized after March 31, 2000, and with any net profits of the wind-down to be used to retire the province's debt.

Be it resolved that the Legislative Assembly urge the Government to undertake a formal comparison of the services, costs and outcomes provided by public and private sectors where services are provided for the Department of Family and Social Services, specifically Child Welfare, Day Care and Handicapped Children's Services.

Be it resolved that the Legislative Assembly urge the Government to increase public visibility of prevention and treatment addiction programs, in particular those programs addressing the abuse of alcohol by teens, by working in cooperation with community-based support services.

#### **18. 531.** Ms Blakeman to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to eliminate health care premiums for all seniors.

#### **19. 532.** Mr. Broda to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to consider enabling the Tire Recycling Management Association of Alberta to accept tires from off-highway vehicles and other previously exempt tires for inclusion in the scrap tire processing and recycling industry to be processed in an environmentally acceptable manner.

#### **20. 533.** Dr. Nicol to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to revise the Farm Income Disaster Program so that it helps all farmers whose operations are viable in the long term, but who are experiencing short term disaster.

## **21. 534.** Mrs. O'Neill to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to develop performance measures applicable to Alberta's varied climates to allow for thorough testing of building products prior to them being added to the Building Code.

Be it resolved that the Legislative Assembly urge the Government to commission an independent review to evaluate the performance and cost-effectiveness of Delegated Administrative Organizations.

Be it resolved that the Legislative Assembly urge the Government to identify and eliminate barriers to employment on the basis of the grounds identified in the Human Rights, Citizenship and Multiculturalism Act.
