Written Questions

WQ231. Mr. Sapers to ask the Government the following question (Due Day 60):

What is the revenue recovery or the economic offset of the \$600 million single rate tax proposal for 2003-04, 2004-05, 2005-06, and 2006-07, and how much of the revenue recovery or economic offset in each fiscal year is accounted for by the elimination of the 8% surtax, the elimination of the 0.5% flat tax, the increase in the personal and spousal exemptions to \$11,620, the increase in the personal and spousal exemptions in the 1999 federal budget, and the introduction of the 11% single rate?

WQ232. Mr. Sapers to ask the Government the following question (Due Day 60):

How much of the \$120 million economic offset or revenue recovery projected in 2002-03, as cited on page 17 of Budget 1999: Government of Alberta Fiscal Plan, results from the elimination of the 8% surtax, from the increase in the personal and spousal exemptions contained in the 1999 federal budget, from the elimination of the 0.5% flat tax, from the increase in the personal and spousal exemptions to \$11,620, and from the introduction of the 11% single rate?

WQ237. Ms Carlson to ask the Government the following question (Due Day 64):

How much did Alberta Environmental Protection spend on conservation education in the areas of fisheries and hunting respectively, each year from April 1, 1991 to March 31, 1999, and through which programs was this administered?

WQ242. Dr. Nicol to ask the Government the following question (Due Day 65):

What are the estimated costs of operating Alberta's trade offices and trade consultants under contract abroad for the fiscal year 1998-99, broken down by accommodation costs and salary ranges for: consultants, clerical staff, commercial officers and posted staff?

WQ243. Mrs. Soetaert to ask the Government the following question (Due Day 65):

How much did the former Department of Transportation and Utilities spend in each of the fiscal years 1990-91, 1991-92, 1992-93 and 1993-94 for work conducted by department staff pertaining to primary highway maintenance with respect to supervision, inspection and audit?

WQ244. Mrs. Soetaert to ask the Government the following question (Due Day 65):

How much did the former Department of Transportation and Utilities spend in the fiscal year 1998-99 for work conducted by department staff pertaining to primary highway maintenance with respect to supervision, inspection and audit?



WQ245. Mrs. Soetaert to ask the Government the following question (Due Day 65):

How many staff (full time equivalents) were employed by the former Department of Labour to investigate all industrial accidents, including those in mining and off-highway logging, between April 1, 1992 and March 31, 1993 and between April 1, 1998 and March 31, 1999?

WQ246. Mr. White to ask the Government the following question (Due Day 65):

How many Alberta Environment staff and how many people on contract were available to fight forest fires on April 1, 1999, July 1, 1999 and October 1, 1999 and what were the equivalent numbers for the same dates in 1998?

WQ247. Mr. White to ask the Government the following question (Due Day 65):

What base resources were available to fight forest fires in Alberta at the beginning of the 1992, 1993, 1998 and 1999 fire seasons, including the number and type of air tankers, number and type of helicopters and number and size of wildland firefighting units?

WQ252. Mrs. Soetaert to ask the Government the following question (Due Day 65):

How many accidents involving log-haul trucks on off-highway roads were investigated each year from April 1, 1992 to March 31, 1999, in how many cases was the weight load checked, in how many cases was the weight load in excess of the rated vehicle capacity (as prescribed in the Canada Motor Vehicle Safety Regulations) and of those cases, in how many was the weight load in excess of the Alberta permitted winter weight?

WQ254. Ms Carlson to ask the Government the following question (Due Day 65):

What was the total number of contaminated sites recorded by Alberta Environmental Protection on March 31, 1999, how many of these were underground petroleum storage sites, how many of the remaining sites were classified as severely, moderately or lightly contaminated, how many were unclassified and how many in each category had been visited and reviewed between April 1, 1998 and March 31, 1999?

WQ255. Ms Leibovici to ask the Government the following question (Due Day 66):

How many ultrasounds were performed by each Regional Health Authority for the calendar years 1992, 1995 and 1998?

Be it resolved that the Legislative Assembly urge the Government to continue a reconfigured Special Places program until it is complete and to establish a panel of independent scientific experts to advise the Government on what areas need further protection to conserve the biodiversity of all ecoregions in the province.

2. 517. Mr. Sapers to propose the following motion:

Be it resolved that the Legislative Assembly establish an all-party Select Committee of the Legislative Assembly on the Future of the Alberta Treasury Branches to seek the input of Albertans through public hearings.

3. 518. Mr. Strang to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to make more bursaries and student loans available for students who have to relocate to one of Alberta's major urban centres to attend post-secondary school.

4. **519.** Mr. Dickson to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to refer all provincial user fees, licences, and premiums to the Standing Committee on Law and Regulations for review.

5. 520. Mr. Johnson to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to implement strategies aimed at increasing the opportunity for Alberta students to participate in student exchange programs, particularly with respect to learning new languages, and to initiate new international student exchange partnerships.

6. 521. Mr. Gibbons to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to engage in public consultation about an alternative funding model for public education.

7. 522. Ms Leibovici to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to increase funding for long term care to provide better access and to ensure that individuals are able to remain in their home communities when they require long term care.

8. 523. Mr. Yankowsky to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to encourage motorists to practice safe driving by not using hand held cellular phones while operating a vehicle.

9. 524. Dr. Pannu to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to introduce legislation which requires employers to provide pro-rated benefits to part-time and casual workers that are equivalent to those provided to full-time workers; extends the scope of employment standards, health and safety, and workers' compensation legislation to farms and ranches employing three or more workers; imposes mandatory penalties on employers who repeatedly violate employment standards; enables the Labour Relations Board to impose first collective agreements; bans the use of replacement workers during a legal strike or lockout; restores full collective bargaining rights, including the right to strike, to nurses, civil servants and other public sector workers providing non-emergency services.

10. 525. Mrs. Gordon to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to explore an alternative source of funding for education rather than generating revenue for this purpose through property taxes.

Be it resolved that the Legislative Assembly urge the Government to conduct an independent review of student costs incurred in accessing post-secondary education programs.

12. 527. Mr. Magnus to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to make it a requirement that Alberta's public schools provide for the singing of our National Anthem once per day.

13. 528. Mr. White to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to consider getting out of the business of direct loans and guarantees to the private sector through the wind-down of the Alberta Opportunity Company, with no new loans and guarantees to be authorized after March 31, 2000, and with any net profits of the wind-down to be used to retire the province's debt.

Be it resolved that the Legislative Assembly urge the Government to undertake a formal comparison of the services, costs and outcomes provided by public and private sectors where services are provided for the Department of Family and Social Services, specifically Child Welfare, Day Care and Handicapped Children's Services.

Be it resolved that the Legislative Assembly urge the Government to increase public visibility of prevention and treatment addiction programs, in particular those programs addressing the abuse of alcohol by teens, by working in cooperation with community-based support services.

Be it resolved that the Legislative Assembly urge the Government to eliminate health care premiums for all seniors.

17. 532. Mr. Broda to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to consider enabling the Tire Recycling Management Association of Alberta to accept tires from off-highway vehicles and other previously exempt tires for inclusion in the scrap tire processing and recycling industry to be processed in an environmentally acceptable manner.

18. 533. Dr. Nicol to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to revise the Farm Income Disaster Program so that it helps all farmers whose operations are viable in the long term, but who are experiencing short term disaster.

19. 534. Mrs. O'Neill to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to develop performance measures applicable to Alberta's varied climates to allow for thorough testing of building products prior to them being added to the Building Code.

20. 535. Ms Paul to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to commission an independent review to evaluate the performance and cost-effectiveness of Delegated Administrative Organizations.

21. 536. Mr. Pham to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to consider reinvesting a percentage of VLT (video lottery terminal) revenues into an endowment fund for primary and secondary education.

22. 537. Mr. Severtson to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to press the Federal Government to implement the recommendations outlined in the Grain Handling and Transportation Review prepared by the Hon. Willard Estey.

23. 538. Dr. Pannu to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to not proclaim Bill 27 (the Electric Utilities Amendment Act, 1998) and instead appoint a broadly based task force to investigate and hold public consultations on all aspects of Alberta's electrical system.

24. 539. Mrs. Gordon to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to give priority to preventative health care through early diagnosis, treatment, medication and procedures that would benefit Albertans and promote a pro-active and efficient health care system over the long term.

Be it resolved that the Legislative Assembly urge the Government to pursue the possibility of allowing Albertans to opt out of the Canada Pension Plan in favour of a mandatory, personal Retirement Savings Plan (RSP).

Be it resolved that the Legislative Assembly urge the Government to establish a stable and predictable funding framework for Alberta municipalities.

Be it resolved that the Legislative Assembly urge the Government to identify and eliminate barriers to employment on the basis of the grounds identified in the Human Rights, Citizenship and Multiculturalism Act.

Be it resolved that the Legislative Assembly urge the Government to work with the private sector and municipalities to develop solutions to the housing crisis in urban Alberta.

30. 545. Mr. Herard to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to recognize best practices (the most effective and efficient treatment practices) and centres of excellence (specialized service providers) for youth addiction and youth offenders' rehabilitation and ensure that centres of excellence in-service training is available to all appropriate professional service providers.

Be it resolved that the Legislative Assembly urge the Government to press the Federal Government to adopt the ten proposed Young Offenders' Act amendments agreed to by Alberta, Manitoba, Ontario and Prince Edward Island on October 30, 1998.

Be it resolved that the Legislative Assembly urge the Government to implement strategies which would provide necessary treatment for offenders with mental health problems, utilizing appropriate treatment facilities and programs within, and whenever possible, outside the justice system.

Be it resolved that the Legislative Assembly urge the Government to examine options for granting longer-term tenure to those who hold timber quotas and forest management agreements, in order to increase fibre production and encourage intensive forest management.

Be it resolved that the Legislative Assembly urge the Government to acknowledge and adopt the Declaration on the Canadian Family as developed by participants attending the Ottawa Conference on the Family held from October 1 to 3, 1998.

Be it resolved that the Legislative Assembly urge the Government to include Regional Health Authorities (RHAs), universities, colleges, technical institutes, and Delegated Administrative Organizations (DAOs) within the Government's consolidated financial statements.

Be it resolved that the Legislative Assembly urge the Government to ensure that all communities have access to effective and efficient air and ground ambulance services.

Be it resolved that the Legislative Assembly urge the Government to include, in the measurable outcomes and goals of government departments and government-funded agencies, the management and measurement of continuous improvements in the efficiency of all government departments and publiclyfunded organizations to free up resources for high-priority areas.

Be it resolved that the Legislative Assembly urge the Government to lobby the Federal Government to spend at least 50 percent of the money collected through federal taxes on automotive fuels on highways in the province of origin.
