Be it resolved that the Legislative Assembly urge the Government to require that the measurable outcomes and goals for government departments and government-funded agencies include targets for improvements in efficiency in their measurable outcomes and goals to free up resources for all high priority areas.

Be it resolved that the Legislative Assembly urge the Government to work with Criminal Intelligence Service Alberta to enhance collaborative partnerships and coordinated programs with various levels of government, policing agencies, and the public to effectively combat organized crime and terrorism to preserve the wellness, safety, and security of our communities.
