Be it resolved that the Legislative Assembly urge the Government to work with Criminal Intelligence Service Alberta to enhance collaborative partnerships and coordinated programs with various levels of government, policing agencies, and the public to effectively combat organized crime and terrorism to preserve the wellness, safety, and security of our communities.

Be it resolved that the Legislative Assembly urge the Government to ensure fair and equitable dealings between commercial landlords and their tenants.

Be it resolved that the Legislative Assembly urge the Government to implement strategies that would provide the necessary treatment for offenders with mental health problems by utilizing appropriate treatment facilities and programs within, and whenever possible, outside the justice system.
