**506.** Mr. Feehan to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to amend the necessary regulations and policies to encourage micro-generators to contribute more renewable electricity to the grid, such as locally generated wind and solar.

**507.** Mr. Shepherd to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to consider amendments to the Gaming and Liquor Regulation, Alta. Reg. 143/96, that would extend the hours associated with the provision of liquor for venues that offer live music and to consider supporting further initiatives that will allow the live music industry in Alberta to prosper and grow.

**508.** Mrs. Schreiner to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to review current practices and regulations regarding sprinkler installation to determine whether sprinkler system safety would be improved by the implementation of a mandatory system of training and certification for sprinkler system installers.

**509.** Ms McPherson to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to take steps to diversify the economy and become a world leader by introducing legislation that would promote the development and proliferation of Alberta's alternative energy and technology industry.

**510.** Dr. Swann to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to implement a system whereby all parents and legal guardians who opt not to vaccinate their preschool and school-aged children against vaccine-preventable diseases will be advised of the risks and potential consequences of doing so and will be required to sign a waiver confirming that they understand and accept the risks and potential consequences of their decision.

**511.** Mr. Clark to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to require all public, separate, private, and charter school boards to implement Bill 10, An Act to Amend the Alberta Bill of Rights to Protect our Children, as passed by the Assembly on March 10, 2015, by adopting a detailed policy on or before March 31, 2016, containing clear guidelines for staff, students, and boards to address the specific challenges facing lesbian, gay, bisexual, transgender, queer/questioning and plus (LGBTQ+) students, and if a board's policy does not meet the legislated requirements as determined by the Minister of Education, the Minister shall impose an appropriate policy on that board.

**512.** Ms McLean to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to conduct a review of the Post-secondary Learning Act to ensure that the Act and regulations protect the right to a meaningful collective bargaining process and that the Act and regulations do not infringe on the constitutional guarantee of freedom of association of the students, faculty, and staff.

**513.** Mr. Coolahan to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to introduce amendments to the Municipal Government Act to give municipalities the authority to ensure additional affordable housing is created including inclusionary zoning and other initiatives.

**514.** Mr. Ellis to propose the following motion:

Be it resolved that the Legislative Assembly support legislation to amend the Seniors Advisory Council for Alberta Act to provide for an Alberta Seniors Charter of Rights that would ensure seniors of the following: (a) the highest level of dignity, respect, and treatment regardless of their situation; (b) access to seniors' housing which is safe, affordable, and provides a healthy environment; (c) access to programs which would help them remain physically active and participate within their communities; and (d) access to the highest quality of mental health care programs, treatments, and support.

Be it resolved that the Legislative Assembly urge the Government to commit to retaining farming and ranching operations as an excluded occupation in the Occupational Health and Safety Act.

Be it resolved that the Legislative Assembly urge the Government to strengthen the provincial budget process by introducing legislation that would restore both the Government Accountability Act and the Fiscal Responsibility Act as a first step toward restoring transparency to the Government's finances.

Be it resolved that the Legislative Assembly appoint a committee of the Assembly to examine the extent of fraud in our health care system and to develop a provincial health care fraud reduction strategy.

Be it resolved that the Legislative Assembly urge the Government to commit to a traffic congestion reduction strategy for Deerfoot Trail in Calgary that will ensure that the average peak time traffic is reduced annually by a minimum of five per cent between December 2015 and December 2018.
