- (c) conscience rights are respected while ensuring the right of patients to access this service;
- (d) the practice of medical assistance in dying is closely monitored and measures regulating medical assistance in dying are reviewed within one year.

Be it resolved that the Legislative Assembly *urge the Government to introduce legislation that would establish* an Alberta Seniors Charter of Rights that would ensure seniors (a) are given the highest level of dignity, respect, and treatment regardless of their situation; (b) have access to seniors' housing which is safe, affordable, and provides a healthy environment; (c) have access to programs which would help them remain physically active and participate within their communities; and (d) have access to the highest quality of mental health care programs, treatments and support.
