Be it resolved that the Legislative Assembly urge the Government to review section 85(1) of the Child, Youth and Family Enhancement Act, and section 25(2)(d)(iii) of Adoption Regulation AR 187/2004, with a view to removing the prohibition on prospective adoptive parents that currently prevents them from advertising and publishing a profile.

Be it resolved that the Legislative Assembly urge the Government to increase its efforts to conserve and manage public lands in Alberta's headwater regions to optimize downstream water security for future generations of Albertans.

Be it resolved that the Legislative Assembly *urge the Government to introduce legislation that would establish* an Alberta Seniors Charter of Rights that would ensure seniors (a) are given the highest level of dignity, respect, and treatment regardless of their situation; (b) have access to seniors' housing which is safe, affordable, and provides a healthy environment; (c) have access to programs which would help them remain physically active and participate within their communities; and (d) have access to the highest quality of mental health care programs, treatments and support.
