Reg. 192/2015, with the intent to ensure accessibility for Albertans that exceeds the base requirements of the Alberta Building Code 2014.

Be it resolved that the Legislative Assembly urge the Government to recognize the first week of February as World Interfaith Harmony Week in support of the United Nations General Assembly resolution 65/5.

Be it resolved that the Legislative Assembly urge the Government to establish a special committee of the Assembly to assess the financial impact of the carbon levy on organizations that provide front line care to seniors in Alberta including but not limited to for-profit organizations, not-for-profit organizations, faith-based organizations, and government owned and operated facilities; and in conducting its review the committee shall consult with key public, private, and non-profit stakeholders and make recommendations for the mitigation of any impacts deemed a threat to the provision of front line care.

Be it resolved that the Legislative Assembly urge the Government to consult with physicians and optometrists and make recommendations on possible amendments to the Traffic Safety Act to address patients who in the opinion of a physician or optometrist have a medical condition that makes it dangerous for them to drive a motor vehicle.
