Be it resolved that the Legislative Assembly urge the Government to recognize the first week of February as World Interfaith Harmony Week in support of the United Nations General Assembly resolution 65/5.

509. Mr. Gotfried to propose the following motion:

Be it resolved that the Legislative Assembly establish a special committee to assess the financial impact of the carbon levy on organizations that provide front line care to seniors in Alberta including but not limited to for-profit organizations, not-for-profit organizations, faith-based organizations, and government owned and operated facilities; and in conducting its review the committee shall consult with key public, private, and non-profit stakeholders and make recommendations for the mitigation of any impacts deemed a threat to the provision of front line care.

Be it resolved that the Legislative Assembly urge the Government to consult with physicians and optometrists and make recommendations on possible amendments to the Traffic Safety Act to address patients who in the opinion of a physician or optometrist have a medical condition that makes it dangerous for them to drive a motor vehicle.

Be it resolved that the Legislative Assembly urge the Government to recognize a day each year to promote the awareness and prevention of concussions.

Be it resolved that the Legislative Assembly urge the Government to consult with stakeholders and Albertans to study the benefits and challenges of a presumed consent model for organ donation in Alberta and report the findings to the Legislative Assembly no later than one year following the passage of this motion.

Be it resolved that the Legislative Assembly urge the Government to improve the land exchange process for Crown and public lands to make it more efficient and transparent.

514. Ms Renaud to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to examine strategies for reducing barriers to abortion and reproduction health services in rural and northern Alberta.

515. Mr. Shepherd to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to provide enhanced labour protection for freelance workers, such as self-employed persons offering services to multiple clients.

- Be it resolved that the Legislative Assembly urge the Government to support renewable energy projects that are fully or substantially owned by co-ops, communities, farmer associations, First Nations, Metis, and individuals.

- Be it resolved that the Legislative Assembly urge the Government to increase Albertans' capacity and access to micro-generation and geo-thermal technologies.

- Be it resolved that the Legislative Assembly urge the Government to recognize the Komagata Maru incident.

- Be it resolved that the Legislative Assembly urge the Government to work with Alberta Health Services to find a cost-neutral means, by November 30, 2018, of removing the cap on midwifery funding to ensure that midwifery is an available birthing option to all women.

- Be it resolved that the Legislative Assembly urge the Government to increase the number of public long-term care spaces available to Albertans.
