Motions Other Than Government Motions

501. Mr. Dach to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to require time limits on restrictive covenants registered by landowners against a certificate of title for a grocery store property that prohibits competitors from opening a similar store on that property once the property is sold.

502. Ms Jabbour to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to introduce legislation that would create a mental health bill of rights to ensure individuals with mental health and substance use disorder issues have the following rights: (a) the right to receive mental health services appropriate for the needs of the individual; (b) the right to be treated by those with whom they interact in a courteous and respectful manner, including the use of terminology that respects the dignity and autonomy of the individual; and (c) the right to reasonable and timely access to appropriate mental health and addiction treatment services.

503. Mr. Nixon to propose the following motion:

Be it resolved that the Legislative Assembly honour the victims of all genocides recognized by the Parliament of Canada – including the Holocaust, the Armenian Genocide, the genocide against the Tutsi in Rwanda, and the ongoing genocide of the Yazidi people by the Islamic State – by recognizing April as Genocide Remembrance, Condemnation and Prevention Month.

504. Mr. Loewen to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to negotiate a new, fair, and equitable equalization formula with the federal government and that any new formula be presented to the people of Alberta through a referendum.

505. Ms Sweet to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to introduce amendments to the Traffic Safety Act to allow variable speed limits on all major provincial highways when adjustments are required due to traffic or unfavourable weather conditions.

506. Mrs. Pitt to propose the following motion:

Be it resolved that the Legislative Assembly conduct a comprehensive review of the Protection of Children Abusing Drugs Act, table the results of the review in the Assembly, and urge the Government to explore additional ways to enhance support for families with children suffering from drug addiction, including long-term rehabilitation.

507. MLA Loyola to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to conduct a review of the Local Authorities Election Act and consider amendments that would allow permanent residents living in Alberta to vote in municipal elections.

508. Mr. Stier to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to immediately discontinue serving meals that have been previously cooked, frozen, and then reheated to Albertans living in supportive and assisted living facilities and begin serving only fresh food, cooked and prepared onsite, within six months from the date this motion is passed.

509. Mr. McIver to propose the following motion:

Be it resolved that the Legislative Assembly has lost confidence in the Government as a result of, but not limited to, its lack of forthright fiscal accounting to Albertans for the budgetary effect of the oil price differential, which has in turn been caused by the Government's inability to secure the Trans Mountain Expansion Project or Keystone XL Pipeline.

510. Mr. Coolahan to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to ensure Albertans are effectively represented by continuing to strengthen democracy and democratic institutions in the province.

511. Mr. Schneider to propose the following motion:

Be it resolved that the Legislative Assembly urge the federal government to remove "fire disturbance" from the definition of a disturbed habitat as found in the Species at Risk Guidelines: Range Plan Guidance for Woodland Caribou, Boreal Population.

512. Mr. Panda to propose the following motion:

Be it resolved that the Legislative Assembly urge the federal government to streamline its regulatory approval process to support the establishment of a national transportation and utility corridor, from the Atlantic to the Pacific coasts, north of the existing Trans-Canada Highway, in order to facilitate the construction of pipelines, power lines, railways, highways, and new communities, and to help access new markets and well-paying jobs for Canadians.

513. Mr. Smith to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to hold transparent, accessible, and open-minded consultations on the proposed Bighorn Country land-use plan similar to the process used to prepare the North Saskatchewan Regional Plan, while recognizing the ongoing conservation efforts by local communities in the Bighorn region.

514. Ms Babcock to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to pursue low cost remedial measures for mobile home owners seeking to resolve tenancy related matters, such as access to the Residential Tenancy Dispute Resolution Service.

516. Ms Luff to propose the following motion:

Be it resolved that the Standing Committee on Privileges and Elections, Standing Orders and Printing review and develop recommendations for the implementation of the following proposed changes to the Standing Orders of the Legislative Assembly and that the Committee submit its report to the Assembly on or before December 16, 2019:

- 1) Referral of all bills to a standing committee of the Legislative Assembly for review in place of Committee of the Whole consideration,
- 2) Election of all chairs of standing and special committees by the membership of the committee through secret ballot, and
- 3) A requirement for the membership of the Special Standing Committee on Members' Services to include at all times at least one independent Member or a Member of an opposition caucus other than the Official Opposition.

517. Mr. Cooper to propose the following motion:

Be it resolved that the Legislative Assembly support amendments to the Constitution of Canada to limit the powers of the Prime Minister of Canada in relation to Senate appointments by implementing an equal and elected Senate, and further urge the Government of Alberta to re-introduce the Senatorial Selection Act.

518. MLA McPherson to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to introduce all necessary legislation to recognize housing as a human right in Alberta.

519. Mr. Dang to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to recognize the atrocities of the Nanjing Massacre.

520. Mr. Hinkley to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to take the necessary measures to allow First Nations and Metis individuals to change at no extra cost their current name to one that better reflects their identity and heritage, in order to further acknowledge the spoken and recognized languages of First Nations and Metis Albertans.
