510. Mr. Dyck to propose the following motion (replaced):

Be it resolved that the Legislative Assembly urge the Government to recognize

- *(a) the importance of the family unit in building a resilient, vibrant and healthy society, and*
- (b) the rights of parents and guardians to have the primary responsibility for the upbringing, development, education, health care and well-being of their children and, except in cases of child abuse or neglect, these duties should not be assumed by any other individuals or institutions within our society.
- **511.** Mr. Haji to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to introduce a Bill that, if enacted, would prohibit, subject to any applicable exemption based on a demonstrated public health and safety risk, a professional regulatory body from including Canadian work experience or experiential training as a requirement to obtain the necessary credentials to work in that profession in Alberta.

512. Mr. McDougall to propose the following motion:

Be it resolved that the Legislative Assembly

- (a) support the Government's ongoing commitments to
 - i) review Alberta's water management strategy to increase the availability of water and water licences,
 - 3

- ii) evaluate potential long-term infrastructure investments to ensure the sustainable management and safeguarding of water resources for the benefit of all Albertans, and
- (b) urge the Government to expand these commitments by undertaking a comprehensive and updated assessment of water resources in the province, including the consideration of inter-basin water transfer as a means of optimizing the use of existing water resources.
- **513.** Mr. Ellingson to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to introduce a Bill to amend the Alberta Sovereignty Within a United Canada Act that, if enacted, would require, on the introduction of a motion under section 3 of the Act, that the Government

- (a) conduct an economic impact study on the potential effects of implementing the matters proposed in the motion, and
- (b) immediately publish the results of that study to ensure that Members are informed, before they vote on that motion, in respect of all potential investment impacts due to regulatory or policy uncertainty, potential job losses, and potential negative impacts on the provincial economy.
- **514.** MLA Batten to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to adjust the maximum age of eligibility for financial supports available under the Transition to Adulthood Program (TAP) from the day before a participant's 22nd birthday to the day before the participant's 24th birthday for the following purposes:

- (a) to ensure that the maximum age of eligibility for all supports available under the TAP program is consistent, and
- (b) to remove a barrier that otherwise may prevent a young adult from achieving their full potential.

Be it resolved that the Legislative Assembly urge the Government to undertake or commission a study to identify and assess

- (a) all revenue from Albertans paid to the federal government compared to revenue from other provinces since 2015;
- (b) all direct and indirect expenditures from the federal government to Albertans compared to such expenditures to other provinces since 2015; and
- (c) the total economic impact on Albertans from federal government policies and actions since 2015.

Be it resolved that the Legislative Assembly urge the Government to consider taking the necessary steps to develop an auxiliary workforce program for local residents, volunteer associations, and landowners to supplement the work of first responders during emergencies and disasters.

517. Mr. Cyr to propose the following motion:

Be it resolved that the Legislative Assembly

- (a) recognize the history of firearms use in Alberta from the earliest days of the fur trade by both Indigenous and non-Indigenous Albertans and that the use of firearms is a necessary tool to preserve life, property and economic livelihoods for those Albertans involved in economic activity such as farming, ranching and resource extraction, all of which entail close contact with wildlife given Alberta's vast wilderness; and
- (b) urge the federal government to respect the rights of law-abiding firearms owners.

Be it resolved that the Legislative Assembly urge the Government to undertake a policy review, with the objective of expanding protection for Albertans who are at risk of anaphylaxis caused by severe life-threatening allergic reactions, on the feasibility of facilitating the availability and use of epinephrine autoinjectors by the following categories of entities that interact with the public:

- (a) businesses,
- (b) municipal fire departments,
- (c) emergency medical services operators,
- (d) school bus carriers.

Be it resolved that the Legislative Assembly urge the federal government to recognize the Government of Alberta's

- (a) role as a reliable and responsible energy supplier, and
- (b) efforts to

 - bring Alberta energy products to international markets based on the demand for ethically sourced oil and gas and worldwide energy security.

How many audits or investigations were conducted under the Nursing Homes General Regulation, the Co-ordinated Home Care Program Regulation or any ministerial directive made under the Regional Health Authorities Act that resulted in a finding of a contravention by an operator of the Continuing Care Health Services Standards (as amended July 16, 2018), during the period from January 1, 2023, to December 31, 2023?

WQ2. Hon. Ms Sigurdson to ask the Government the following question (Due Day 53):

How many investigations were undertaken by the Ministry of Health in response to complaints about an operator under the Nursing Homes Act during the period from January 1, 2023, to December 31, 2023?

How many operators were subject to a penalty as a result of a contravention of the Continuing Care Health Services Standards (as amended July 16, 2018) required under the Nursing Homes General Regulation, the Coordinated Home Care Program Regulation or any ministerial directive made under the Regional Health Authorities Act, during the period from January 1, 2023, to December 31, 2023?

WQ4. Hon. Ms Sigurdson to ask the Government the following question (Due Day 53):

How many audits or investigations were undertaken by the Ministry of Health, during the period from January 1, 2023, to December 31, 2023, in respect of a complaint made under the Supportive Living Accommodation Licensing Act?

WQ5. Hon. Ms Sigurdson to ask the Government the following question (Due Day 53):

How many audits or investigations were conducted under the Nursing Homes General Regulation, the Co-ordinated Home Care Program Regulation or any ministerial directive made under the Regional Health Authorities Act, in respect of compliance by an operator with the Continuing Care Health Services Standards (as amended July 16, 2018), during the period from January 1, 2023, to December 31, 2023?

WQ6. Hon. Ms Sigurdson to ask the Government the following question (Due Day 53):

How many operators were investigated, during the period from January 1, 2023, to December 31, 2023, for failing to provide the minimum average hours of nursing and personal services required under section 14 of the Nursing Homes Operation Regulation (Alta Reg 258/1985)?

That an Order of the Assembly do issue for a Return showing: A list of all grants, organized by year, provided by the Government to the non-profit corporation Results Driven Agriculture Research (RDAR) during the period from April 1, 2019, to March 31, 2024.

MR5. Mr. Dach to propose the following motion (Due Day 53):

That an Order of the Assembly do issue for a Return showing: Copies of all documents prepared by the Government relating to the effectiveness of salt brine solutions for de-icing provincial highways.

MR6. Mr. Dach to propose the following motion (Due Day 53):

That an Order of the Assembly do issue for a Return showing: A list of all amendments made during the period from March 31, 2019, to March 31, 2024, to provincial highways maintenance contracts in respect of maintenance service levels.

MR7. Mr. Dach to propose the following motion (Due Day 53):

That an Order of the Assembly do issue for a Return showing: Copies of all documents, reports, studies, and communications, prepared by the Government during the period from May 1, 2019, to March 31, 2024, related to the consideration of raising the speed limit on provincial highways to 120 kilometres per hour.

That an Order of the Assembly do issue for a Return showing: A list of all Community Airport Program funding recipients for each year during the period from May 1, 2019, to March 31, 2024, and, in respect of each recipient, the amount of funding received and description of the project for which funding was received.

That an Order of the Assembly do issue for a Return showing: Copies of all documents, studies, data and communications prepared by the Government that were considered by the Executive Council in relation to the decision to rescind, on February 28, 2023, the proclamation that would have brought into force on March 1, 2023, the Traffic Safety Amendment Act, 2022, which amends the Traffic Safety Act to require drivers in all lanes of traffic going in the same direction on divided highways or travelling in either direction on single lane highways to slow to 60 kilometres per hour when passing stopped vehicles with flashing lamps.

That an Order of the Assembly do issue for a Return showing: A list showing the number of Albertans, organized by year, paid the basic minimum wage described in section 9(1)(a.1) of the Employment Standards Regulation (AR 14/1997) during the period from June 26, 2019, to March 31, 2024.
