Mr. Wright, Hon. Member for Edmonton-Strathcona, moved that the Bill be amended as follows:

- D. Section 8 is struck out and the following is substituted:
 - 8. Before advising a consumer, the supplier, agent or financial planner must ask a consumer
 - (a) why the consumer needs advice, and

(b)what purpose the consumer intends to achieve by investing,

and must give advice or propose a named financial product to the consumer that is appropriate in light of the consumer's response.

- E. Section 13 is amended
 - (a) by adding the following after subsection (1)
 - (1.1) (a) any provision in a document that exempts the seller of the financial product from liability or restricts that liability, wherever the provision is located in the document, must be drawn to the attention of the consumer on the first page of the document, in bold type, as being a condition under which liability may be limited;

(b) any provision that is not drawn to the attention of the consumer in accordance with clause (a) is void.

The following Bill was taken under consideration:

Bill 36 Constitution of Alberta Amendment Act, 1990 — Hon. Mr. Rostad

Mr. Hawkesworth, Hon. Member for Calgary-Mountain View, moved that the Bill be amended as follows:

- A. The preamble is amended by adding "Whereas Section 43 of the Constitution Act, 1982 provides for an amendment to the Constitution of Canada in relation to any provision that applies to Alberta;" after "section 35 of the Constitution Act, 1982".
- B. The following is added after section 9:

"10. The Government of Alberta, following proclamation, will lay before the Legislative Assembly of Alberta at the earliest opportunity when it is then sitting, a resolution in the form appended hereto and will seek to authorize a proclamation to be issued by the Governor General under the Great Seal of Canada to amend the Constitution of Canada under Section 43 and the Alberta Act, to give effect to this Act."

296. Mr. Decore to propose the following motion:

Be it resolved that the Legislative Assembly endorse the principle that no constitutional change will be approved by the Legislative Assembly in future without prior reference to public hearings; and

That the Legislative Assembly establish a Standing Committee on Constitutional Matters which would have representation from all recognized parties in the Legislature, with Party leaders as ex-officio members; which would be responsible for holding such hearings and other public hearings on any agreement, resolution, or amendment on constitutional reform; and,

That the Standing Committee be instructed to hold public hearings without delay in order to develop Alberta's agenda for future constitutional change including calling a national constitutional convention, senate reform, aboriginal and minority rights, a Canada clause, and other issues.
