Bill 1 Constitutional Referendum Act – Hon. Mr. Getty

A debate followed.

Mr. Pashak, Hon. Member for Calgary-Forest Lawn, proposed the Bill be amended as follows:

The following is added after section 9:

- 9.1 For the purposes of supporting or opposing any question put to the electors at a referendum
- (a) contributions that may be made to political parties persons or groups of persons may not exceed
  - (i) \$5,000 for any one contributor, and
  - (ii) \$1,000,000 in the aggregate for the total of all funds contributed to all parties, persons or groups campaigning on a particular side of a question put to the electors;
- (b) expenses that may be incurred by political parties, persons or groups of persons may not exceed \$1,000,000 in the aggregate for the total of all expenses of all parties, persons or groups campaigning on a particular side of a question put to the electors.

The following is added after section 9.1:

9.2 The Government of Alberta shall not expend money in the campaign on a particular side of a question put to the electors, except in relation to the express responsibilities of the Government as set out in this Act.
