- (i) place an immediate moratorium on the draining into the McLeod River of raw sewage or wastewater from a stabilization pond by the Pine Shadow Estates Mobile Home Park near Edson, Alberta;

- (ii) revoke Pine Shadow Estates Mobile Home Park's license to operate and periodically drain a wastewater stabilization pond;
- (iii) take steps to ensure Pine Shadow Estates Mobile Home Park addresses its effluent problem in a proper and environmentally responsible manner.

The question being put, the motion was agreed to unanimously.
