# **ROUTINE**

# **Presenting Petitions**

Mr. Dickson, Hon. Member for Calgary-Buffalo, presented a petition from 1,086 Calgarians regarding Government plans to restructure the educational system.

Mr. Henry, Hon. Member for Edmonton-Centre, presented a petition from 405 Calgarians regarding Government plans to restructure the educational system.

Mr. Collingwood, Hon. Member for Sherwood Park, presented a petition from 88 residents of Sherwood Park regarding the maintenance of the Grey Nuns Hospital in Mill Woods as a full-service, active hospital.

Mrs. Soetaert, Hon. Member for Spruce Grove-Sturgeon-St. Albert, presented a petition from Albertans regarding the maintenance of the Misericordia Hospital as a full-service, active hospital.

# **Reading and Receiving Petitions**

On request by Mr. Decore, Hon. Leader of the Official Opposition, the following petition was read and received:

We petition the Legislature to urge the Government to take immediate steps to stop any measures that will reduce the availability of post-secondary programs, and to begin a phased-in approach to ensure accessible post-secondary opportunities for students in the next 10 years.

On request by Dr. Massey, Hon. Member for Edmonton-Mill Woods, the following petition was read and received:

We, the undersigned, petition the Legislative Assembly to urge the Government to maintain the Grey Nuns Hospital in Mill Woods as a full-service, active hospital and continue to serve the South-east end of Edmonton and surrounding area.

On request by Mr. Zariwny, Hon. Member for Edmonton-Strathcona, the following petition was read and received:

We petition the Legislative Assembly to urge the Government to work with student leaders to develop a thoughtful, judicious tuition fees policy that meets the needs of both students and post-secondary institutions.

On request by Mr. Bruseker, Hon. Member for Calgary-North West, the following petition was read and received:

We respectfully request that the Legislative Assembly urge the Government of Alberta to refrain from introducing legislation which would enable the provincial appointment of superintendents and the seizure of locally levied school residential taxes.

#### **Presenting Reports by Standing and Special Committees**

Mr. Renner, Chairman, Standing Committee on Private Bills, presented the following report:

Pursuant to Standing Order 93, I wish to report that the petitions for Private Bills which have been received by the Assembly have been taken under consideration by me as Chairman of the Private Bills Committee, and all the petitions received, with two exceptions, comply with Standing Order 86.

The petition I presented of Leonard Anderson and Mandy Anderson for the Mandy Anderson Adoption Act was advertised prior to November 1, 1993. The petition was advertised in anticipation of being heard last Session. Standing Order 86(1) requires that advertising be commenced not earlier than the November 1st preceding the Session. The petition otherwise complies with the requirements of Standing Order 86.

The second petition is that of Anna-May Woodley for the Travis Trevor Purdy Adoption Act, for which the advertisement will appear in the Alberta Gazette on March 15, 1994. The petition has otherwise complied with the advertising requirements under Standing Order 86.

The Private Bills Committee has had these petitions under consideration and requests that the Assembly unanimously suspend Standing Order 94 with respect to these petitions in order that the Bills may be introduced today and referred to the Committee.

I request the concurrence of the Assembly in this recommendation and report.

The questions being put, concurrence in the report and unanimous consent to waive Standing Order 94 were granted.
