505. Moved by Mrs. Laing:

Be it resolved that the Legislative Assembly urge the Government to ensure that health and safety standards are being met in all Personal Care Facilities by establishing regulations and a comprehensive monitoring system.

A debate followed.

The question being put, the motion was agreed to unanimously.

506. Mr. Mitchell:

Be it resolved that the Legislative Assembly urge the Government to refer the matter of realignment of constituency boundaries (in accordance with direction from recent court decisions, including the Alberta Court of Appeal reference decision) to a member of the Court of Queen's Bench of Alberta to issue a report outlining the necessary process to revise constituency boundaries.

The Speaker ruled that, pursuant to Standing Order 23(e), Beauchesne 566(7) and 513(2) and Erskine May p. 327 regarding anticipation, Motion Other Than Government Motion No. 506 could not proceed and was removed from the Order Paper.

507. Moved by Dr. Massey:

Be it resolved that the Legislative Assembly urge the Government to introduce legislation that would ensure access, by any person who has satisfactorily completed an Alberta High School Diploma, to the first year class of an appropriate provincial post-secondary educational institution.
