#### **511.** Moved by Mrs. Forsyth:

Be it resolved that the Legislative Assembly urge the Government to recommend the Alberta Liquor Control Board (ALCB) to suspend the licences of store owners who sell or serve liquor to minors as follows: for a first offence - warning or suspension of up to thirty days for knowingly serving a minor; for a second offence - thirty days suspension; and for a third offence - license cancellation.

A debate followed.

Mr. Bracko moved the motion be amended by striking out

store owners who sell or serve

and substituting

any person or establishment that sells or serves

A debate followed on amendment.

Mrs. Fritz moved adjournment of the debate on amendment, which was agreed to.
