# **Presenting Petitions**

Mr. Doerksen, Hon. Member for Red Deer-South, presented a petition from 388 members of the medical profession and patients expressing concern regarding Bill 29, Medical Professions Amendment Act, 1997 (24th Legislature, 1st Session).

Mr. Sapers, Hon. Member for Edmonton-Glenora, presented a petition from 70 Edmonton and Spruce Grove residents regarding an amendment to the Legislative Assembly Act which would make it mandatory for the Government to hold two sittings of the Legislative Assembly each year.
