Be it resolved that the Legislative Assembly urge the Government to work in partnership with the Federal Government and the College of Physicians and Surgeons to review federal and provincial *strategies that address unwanted pregnancies and the related issues of teen pregnancies, abortions and the waiting lists for adoptions, and; examine the factors contributing to and means of improving upon the outcomes of these strategies.*

A debate followed.

Pursuant to Standing Order 8(4), the question being put, the motion was agreed to.

511. Moved by Ms Forsyth:

Be it resolved that the Legislative Assembly urge the Government to strongly encourage the Federal Government to move the drug flunitrazepam (Rohypnol) and its related drug family from Schedule 4 of the Controlled Drugs and Substances Act to Schedule 1 in light of its use as a sedative to render a person unconscious for the purpose of sexual assault; properly educate the general public, targeting high school and post-secondary students, about its effects, and the need to seek medical and police attention if it is believed they were a victim of an assault; provide detailed information about this drug to travellers leaving Canada for destinations where this drug is currently legal; and work cooperatively with other governments to ban the use, distribution, and manufacture of this drug.
