Mr. Hancock, Government House Leader, raised a purported question of privilege regarding remarks uttered by Mrs. Sloan, Hon. Member for Edmonton-Riverview. He felt comments the Hon. Member for Edmonton-Riverview had spoken following the tabling by Mr. Friedel, Hon. Member for Peace River, of the Information and Privacy Commissioner's response to Bill 40, Health Information Act, offended the House and brought into question the integrity of the Information and Privacy Commissioner, an Officer of the Legislative Assembly.

The Speaker heard from Mr. Dickson, Official Opposition House Leader; Ms Barrett, Hon. Member for Edmonton-Highlands; Hon. Mr. Havelock, Deputy Government House Leader; Mrs. Sloan, Hon. Member for Edmonton-Riverview; and Mr. Friedel, Hon. Member for Peace River.

Mrs. Sloan, Hon. Member for Edmonton-Riverview, withdrew the offending comment.

The Speaker stated this was a serious situation and invited further comment from Mrs. Sloan, who apologized for the remarks uttered earlier.
