The Speaker took the Chair at 1:00 p.m.

Introduction of New Members

The Speaker announced that he had received from the Chief Electoral Officer of Alberta the report of the Returning Officer for the constituency of Drumheller-Stettler containing the results of the by-election conducted on June 12, 2007, in the constituency and the said report further showed that Jack Hayden was duly elected as the Member for Drumheller-Stettler.

Mr. Hayden joined Hon. Mr. Stelmach, Premier, at the Bar and was then escorted to the Mace. Hon. Mr. Stelmach presented Mr. Hayden to the Speaker and the Hon. Member for Drumheller-Stettler took his seat in the Assembly.

The Speaker then announced that he had also received from the Chief Electoral Officer of Alberta the report of the Returning Officer for the constituency of Calgary-Elbow containing the results of the by-election conducted on June 12, 2007, in the constituency and the said report further showed that Craig Cheffins was duly elected as the Member for Calgary-Elbow.

Mr. Cheffins joined Dr. Taft, Hon. Leader of the Official Opposition, at the Bar and was then escorted to the Mace. Dr. Taft presented Mr. Cheffins to the Speaker and the Hon. Member for Calgary-Elbow took his seat in the Assembly.
