Mr. Elsalhy, Hon. Member for Edmonton-Centre, presented a petition from 266 Albertans urging the Government to ensure that the remuneration paid to employees working with people with disabilities is standardized across the sector, regardless of whether these workers are employed by government, community-based, or private providers; ensure these employees are fairly compensated and that their wages remain competitive with other sectors to reflect the valuable and crucial service they provide; improve employees' access to professional development opportunities (training and upgrading); and introduce province-wide service and outcomes-focussed level-of-care standards.
