Speaker's Statement - Tabling Returns and Reports

Honourable Members, on several occasions the Chair has risen in this House to discuss the issue of tablings. On Thursday, March 12, 2009, an Honourable Member tabled a document on behalf of one of his honourable colleagues, and this document has been brought to the Chair's attention for several reasons. The issues are as follows: it is not clear what the document is about; there's no cover page, no title, and no heading; the document is not dated nor signed, nor is there an author identified. While the document appears to be an excerpt from a document that is part of legal proceedings, there is no indication of what the document is an excerpt from.

Honourable Members, it is important to note that all documents tabled in the House become official records of the Assembly. They are available to the public through the Legislature Library. The description of Sessional Papers in the Votes and Proceedings is an actual description of the document and is not based on the comments of the Member tabling the document. If there is no way of identifying the document, it is difficult for those producing the official records of the Assembly to be accurate in their description of the document. Staff should not be expected to waste time trying to decipher these documents. There is need to set additional guidelines, and the Chair would ask all Honourable Members to follow them.

Copies should be of good quality and legible: five copies collated, stapled or clipped together. Letters should be signed and the name of the sender should be legible. Web site articles should clearly indicate the name of the web site so that we can properly quote the site. Responses to Written Questions and Motions for Returns must indicate that they are such. Please do not table only a set of documents. It should be clear to all of us that the documents are provided as responses. Reports, charts, and similar items must have a title or heading on the document. The general rule is that Members should table documents under Tabling Returns and Reports. The Chair will be advised when tablings do not meet these guidelines, and those purported tablings will be returned to Members.
