Bill 43 Marketing of Agricultural Products Amendment Act, 2009 (No. 2) — Mr. Griffiths

A debate followed.

Ms Blakeman, Hon. Member for Edmonton-Centre, moved the Bill be amended as follows:

- A Section 2 is struck out and the following is substituted:
 - 2 Section 15 is amended
 - (a) by adding "or" at the end of subsection (1)(b) and repealing subsection (1)(c);
 - (b) by repealing subsection 2(d)(viii) and substituting the following:
 (vii) if a service charge is imposed, that it is refundable on the request of a producer, except in the case of a plan respecting producers of
 - (A) beef,
 - (B) pork,
 - (C) lamb, or
 - (D) potatoes,

in which case the plan shall provide that a service charge is not refundable on the request of a producer;

- B Section 3 is amended by adding the following after the proposed section 23(5):
 - (6) Subsections (4) and (5) do not apply to plans respecting producers of
 - (a) beef,
 - (b) pork,
 - (c) lamb, or
 - (d) potatoes,
- C Section 4 is struck out and the following is substituted:

4 Section 24 is amended in subsection (1)(a) by repealing subclause (ii) and substituting the following:

(ii) in the case of a plan respecting producers of beef, pork, lamb or potatoes that is administered by a commission under which the service charges are not refundable, if the amendment is to the effect that the service charges will now be refundable,

- D Section 6 is amended by adding the following after the proposed section 26.1(4):
 - (5) This section does not apply to plans respecting producers of
 - (a) beef,
 - (b) pork,
 - (c) lamb, or
 - (d) potatoes.

A debate followed on the amendment.
