## **Members' Statements**

## **Presenting Petitions**

Mr. Boutilier, Hon. Member for Fort McMurray-Wood Buffalo, presented a petition from 450 Fort McMurray residents urging the Government to not introduce a provincial ambulance service and promote municipal integrated fire and emergency medical services throughout the province.

Mr. Mason, Hon. Member for Edmonton-Highlands-Norwood, on behalf of Ms Notley, Hon. Member for Edmonton-Strathcona, presented a petition from 226 Albertans requesting the Legislative Assembly amend Bill 44, Human Rights, Citizenship and Multiculturalism Amendment Act, 2009, by striking out section 9 to remove (a) the onus on school boards and teachers to enforce parental choice regarding teaching related to sexuality, sexual orientation and religion; and (b) the ability for school boards and teachers to be subjected to complaints before the Human Rights Commission for discussing these matters in class.

#### **Point of Privilege**

Dr. Taft, Hon. Member for Edmonton-Riverview, gave notice of his intention to raise a purported question of privilege under Standing Order 15 regarding the Ethics Commissioner advising Dr. Taft not to participate in debate on Bill 43, Marketing of Agricultural Products Amendment Act, 2009 (No. 2). The decision, which the Ethics Commissioner agreed was improperly broad, prohibited and obstructed Dr. Taft to a degree that jeopardized the adequate disposal of his responsibilities and duties as a Member of the Legislative Assembly.
