Presenting Petitions

Mr. Weadick, Hon. Member for Lethbridge-West, presented a petition from 182 Albertans urging the Government to grandfather the rights and status of all currentlypractising Registered Massage Therapists in Alberta in a manner that they may continue their practice undisturbed and ensure that clients of said therapists will be able to use their insurance coverage in order to pay for massage services from current therapists.

Mr. Weadick, Hon. Member for Lethbridge-West, presented a petition from 319 Albertans urging the Government to grandfather the rights and status of all currentlypractising Registered Massage Therapists in Alberta in a manner that they may continue their practice undisturbed and, when necessary, gradually upgrade to newly-proclaimed standards of training, so as not to force current therapists to lose their ongoing income whilst upgrading and so to ensure that clients of said therapists will be able to use their insurance coverage in order to pay for massage services from current therapists.
