Ms DeLong, Hon. Member for Calgary-Bow, presented a petition from 117 Albertans urging the Government to grandfather the rights and status of all currently-practising Registered Massage Therapists in Alberta in a manner that they may continue their practice undisturbed and, when necessary, gradually upgrade to newly-proclaimed standards of training, so as not to force current therapists to lose their ongoing income whilst upgrading and so to ensure that clients of said therapists will be able to use their insurance coverage in order to pay for massage services from current therapists.
