The following Bill was taken under consideration:

Bill 7 Election Accountability Amendment Act, 2012 — Hon. Mr. Denis

Hon. Mr. Hancock, Government House Leader, requested and received the unanimous consent of the Assembly to shorten the interval between division bells to one minute.

Mr. Saskiw, Hon. Member for Lac La Biche-St. Paul-Two Hills, moved that the Bill be amended as follows:

A Section 58(a)(iv) is amended by striking out paragraph (A) and substituting the following:

- (A) by repealing subclause (vi) and substituting the following:
 - (vi) a corporation that carries on business in Alberta;

B Section 67 is amended by striking out clause (b) and substituting the following:

- (b) in subsection (5)
 - (i) in clause (e) by striking out "within the meaning of subsection 248(1) of the Income Tax Act (Canada)";
 - (ii) in clause (f) by adding "listed in section 1(1)(i), (ii), (iii), (iv), (v), (vi.1), (vi.2), (vi.3), (vi.4) or (vii)" after "prohibited corporation".

C Section 89 is amended in the proposed section 44.2(5)(b) by adding "listed in section 1(1)(i), (ii), (iii), (iv), (v), (vi.1), (vi.2), (vi.3), (vi.4) or (vii)" after "prohibited corporation".

D Section 95 is amended in the proposed section 44.93(2) by striking out "corporation," wherever it occurs.

E Section 100 is amended in the proposed section 51.01(2)(a) by striking out "corporation,".

F The following is added after section 101:

101.1 The Election Finances and Contributions Disclosure Act is amended in the following sections by striking out "corporation," wherever it occurs:
