Committee of the Whole

According to Order, the Assembly resolved itself into Committee of the Whole and the Deputy Speaker left the Chair.

(Assembly in Committee)

Hon. Mr. Denis, Deputy Government House Leader, requested and received the unanimous consent of the Assembly to shorten the interval between division bells to one minute.

The following Bill was taken under consideration:

Bill 30 Building Families and Communities Act (\$) — Hon. Mr. Hancock

Dr. Swann, Hon. Member for Calgary-Mountain View, moved that the Bill be amended in section 2 by adding the following after subsection (3):

- (3.1) The membership of a Council must include at least one member who has involvement and experience with
 - (a) developmental disabilities, and
 - (b) child, youth and family services.

The question being put, the amendment was defeated. With Mr. Rogers at the Table, the names being called for were taken as follows:

Ms Notley, Hon. Member for Edmonton-Strathcona, moved that the Bill be amended in section 8(5) as follows:

- (a) by renumbering the proposed section 1.2 as section 1.2(1);
- (b) by adding to the proposed section 1.2(1) "as described in the regulations," after "has a developmental disability,";
- (c) by adding the following after the proposed section 1.2(1):
 - (2) The director must develop a plan in consultation with the adult, the adult's family or guardian, or existing service provider.;

(d) by adding the following after the proposed section 1.2:

Duty of care to adults with developmental disabilities

- 1.3(1) If the director receives information in the form of a report or any other allegation or evidence that an adult with a developmental disability may be endangered or neglected and is in need of care, the director must investigate the adult's need for care unless the director is satisfied that the information was provided maliciously or is unfounded or that the report or allegation was made without reasonable and probable grounds.
- (2) For the purposes of this section, an adult with developmental disabilities is endangered or neglected and in need of care if
 - (a) the adult has been or there is substantial risk that the adult will be physically or emotionally injured or sexually abused,
 - (b) the guardian of the adult has subjected the adult to or is unable or unwilling to protect the adult from cruel and unusual treatment or punishment, or
 - (c) the guardian of the adult is unable or unwilling to provide the adult with the necessities of life.
- (3) If, after an investigation referred to in subsection (1), the director is of the opinion that the adult is endangered or neglected and in need of care, the director must take whatever action that the director considers appropriate, including the provision of services and supports, to ensure the safety and personal dignity of the adult.
