**Speaker's Statement – Oral Question Period and Members' Statements Rotations**

Honourable Members, before we begin Oral Question Period today, I want to advise you of adjustments that will be made to the Oral Question Period and Members' Statement rotations resulting from the recent changes in caucus memberships. The House Leaders for the Government and Official Opposition caucuses provided my office today with a memo dated November 27, 2014, that enclosed a revised Oral Question Period rotation affecting only positions held by those two caucuses in the rotation.

On days two and four in the Oral Question Period rotation, question 16 will now be asked by a Private Member from the Government caucus, in the positions formerly held by the Official Opposition. Members should note that this change will affect the questions for today, which is day four in the rotation.

The House Leaders' Agreement provided to me earlier today is silent with regard to the Members' Statement rotation. Accordingly, I have tried to preserve the intent of the May 2012 House Leaders' Agreement but have made an adjustment that takes into account the change in caucus composition. It is, of course, open to House Leaders to propose an alternative, if they wish, by way of an agreement concerning Members' Statements.

In the Members' Statement rotation for week four, on Wednesday, the final Members' Statement position will be held by the Government caucus and the Official Opposition will now have only one statement on that day. The current week is week three in the Members' Statement rotation and as a result, this change will not affect the schedule of Members' Statements outlined in the Projected Sitting Days Calendar until Wednesday, December 10, assuming I do not hear from House Leaders before that date.

These changes to the rotations are in addition to the changes I announced on Tuesday, November 18, 2014, at page 11 of Alberta Hansard, changes that were made to accommodate the independent Member.

## **Members' Statements**

Mr. Hehr, Hon. Member for Calgary-Buffalo, made a statement recognizing December 3, 2014, as the International Day of Persons with Disabilities, regarding the barriers faced by people with disabilities, and recognizing the Momo Dance Theatre Group, Champions Career Centre, and Nabel Ramji, who are working to eliminate those barriers.
