Ms Olesen, Hon. Member for Sherwood Park, made a statement regarding issues concerning life lease housing agreements and the need for the Government to conduct a review to ensure seniors are not taken advantage of.

Ms Blakeman, Hon. Member for Edmonton-Centre, made a statement regarding the December 6, 1989, massacre at l'École Polytechnique in Montréal where 14 women were killed and how that event shaped her life and the lives of Canadian women, the committee of women assembled by Ms Blakeman to annually commemorate that day, and recognizing December 6, 2014, as the National Day of Remembrance and Action.

Ms Pastoor, Hon. Member for Lethbridge-East, made a statement recognizing the Lethbridge community, stakeholders, and all levels of government for their work in achieving a significant reduction in homelessness in Lethbridge.

Mr. Quadri, Hon. Member for Edmonton-Mill Woods, made a statement regarding the Government's Employment First Strategy and the Employment First Innovation Fund, both created to create job opportunities for people with disabilities.

Mr. Fox, Hon. Member for Lacombe-Ponoka, made a statement reading from a letter from the Mayor of Ponoka, to Hon. Mr. Dirks, Minister of Education, regarding school infrastructure planning and funding for school playground projects.
