Mr. Barnes, Hon. Member for Cypress-Medicine Hat, moved that the Bill be amended in section 1(15) in the proposed section 23.13

- (a) by adding the following after clause (c):
 - (d) a candidate during an election period.
- (b) by renumbering section 23.13 as section 23.13(1) and by adding the following after subsection (1):
 - (2) In this section,

(a) "benefit", in the case of a candidate, includes an advantage received by the candidate in his or her campaign resulting from an announcement respecting government spending made by the Minister during the election period, unless the announcement is required to be made because of an emergency or other urgent matter relating to public safety;

(b) "candidate" has the meaning given to it in the Election Act;

(c) "election period" means the period commencing with the issue of a writ of election, including a by-election, and ending at the end of the day fixed for voting at the election.
