The Speaker took the Chair at 1:30 p.m.

The Speaker made a statement in recognition of the 26th anniversary of Ms Calahasen, Hon. Member for Lesser Slave Lake, who was elected to the Legislative Assembly on March 20, 1989, and who is the longest-serving woman in the Legislative Assembly of Alberta and the 16th longest-serving Member in the history of this Assembly.
