# **Government Bills and Orders**

#### **Committee of the Whole**

According to Order, the Assembly resolved itself into Committee of the Whole and the Deputy Speaker left the Chair.

(Assembly in Committee)

The following Bill was taken under consideration:

Bill 4 An Act to Implement a Supreme Court Ruling Governing Essential Services — Hon. Ms Gray

Mr. McIver, Hon. Leader of the Progressive Conservative Opposition, moved that the Bill be amended in section 9, in the proposed section 96(1)

(a) by striking out clause (b) and substituting the following:

(b) employees who act as ambulance attendants as defined in the Emergency Health Services Act, and to the extent that they bargain collectively with ambulance attendants, employers who are ambulance operators as defined in that Act,

- (b) in clause (c) by adding "excluding employees to which clause (b) applies" after "all the employees of those employers", and
- (c) in clause (d) by striking out "clause (c)" and substituting "clauses (b) or (c)".

A debate followed on the amendment.

# **Members' Statements**
