Mr. Hinkley, Hon. Member for Wetaskiwin-Camrose, made a statement and read from a letter from Mrs. Hoffman of Viking thanking St. Mary's Hospital in Camrose, the hospital's early stroke discharge team, and others for the care her husband received following the stroke he suffered in November 2015.

Mr. Orr, Hon. Member for Lacombe-Ponoka, made a statement regarding the 2016 Memorial Cup hockey tournament held from May 19 to 29, 2016, in Red Deer, won by the London Knights, the Tour of Alberta to be held in September 2016, and the 2019 Canadian Winter games to be held in central Alberta.

Mr. McIver, Hon. Be it resolved that the Legislative Assembly urge the Government to implement measures to regulate medical assistance in dying, consistent with the decision of the Supreme Court of Canada in Carter v. Canada (Attorney General) and any legislative measures approved by the Parliament of Canada, to ensure that Albertans can benefit from the orderly implementation of this court decision so that:

- (a) Albertans may exercise their rights to access medical assistance in dying;
- (b) appropriate safeguards be put in place to protect vulnerable Albertans;
- (c) conscience rights are respected while ensuring the right of patients to access this service;
- (d) the practice of medical assistance in dying is closely monitored and measures regulating medical assistance in dying are reviewed within one year.

Hon. Mr. Mason, Government House Leader, on behalf of Hon. Ms Larivee, Minister of Municipal Affairs, gave oral notice of the following motion:
