Ministerial Statements

Hon. Ms McLean, Minister of Service Alberta and Minister of Status of Women, made a statement recognizing November 25, 2016, as the International Day for the Elimination of Violence Against Women.

Mr. Jean, Hon. Leader of the Official Opposition, commented on the statement.

Hon. Mr. Mason, Government House Leader, requested and received the unanimous consent of the Assembly to allow a Member of the Progressive Conservative Opposition, the Member for Calgary-Mountain View, and the Member for Calgary-Elbow to comment on the Ministerial Statement.

Mr. Fraser, Hon. Member for Calgary-South East, Dr. Swann, Hon. Member for Calgary-Mountain View, and Mr. Clark, Hon. Member for Calgary-Elbow, then commented on the statement.

Members' Statements

Ms McKitrick, Hon. Member for Sherwood Park, made a statement regarding the work of the recently formed Strathcona County Diversity Committee, which is committed to respect and inclusion in Strathcona County.

Mr. Cooper, Hon. Member for Olds-Didsbury-Three Hills, made a statement regarding the state of public debate, especially with respect to the harassment of women in politics, and the need to elevate public discussion.

Mr. Clark, Hon. Member for Calgary-Elbow, made a statement regarding Nathan, who died from a fentanyl overdose after being unable to find the supports he needed to treat his addiction, and asking the Government to declare the fentanyl crisis a public health emergency.

Mr. Coolahan, Hon. Member for Calgary-Klein, made a statement regarding the necessity of Bill 208, Occupational Health and Safety (Protection from Workplace Harassment) Amendment Act, 2016, which he sponsors, and the need for respect, dignity, and inclusion in politics.

Ms Sweet, Hon. Member for Edmonton-Manning, made a statement regarding her past career as a child protection worker and difficult decisions, challenges, and joys these front-line workers encounter.

Hon. Mr. Mason, Government House Leader, requested and received the unanimous consent of the Assembly to waive Standing Order 7(7) in order to complete the Daily Routine.
