Members' Statements

MLA Loyola, Hon. Member for Edmonton-Ellerslie, made a statement regarding recent discriminatory remarks about MLA Loyola allegedly made by opposition Members and the behaviour of opposition Members in the Assembly.

Mr. W. Anderson, Hon. Member for Highwood, made a statement regarding the difficulties faced by Bruce Bolton in obtaining Persons with Developmental Disabilities (PDD) benefits for his son and the lack of Government response to issues presented by the Wildrose on May 26, 2016, concerning those who are unable to obtain PDD benefits.

Mr. Drysdale, Hon. Member for Grande Prairie-Wapiti, made a statement congratulating the City of Grande Prairie for receiving the 2017 Peace and Friendship Diversity Award for its work to build good relations with indigenous communities.

Ms Renaud, Hon. Member for St. Albert, made a statement regarding several New Democratic Party initiatives in Canada which have become public policy but may be threatened by the proposed United Conservative Party.

Mr. Dang, Hon. Member for Edmonton-South West, made a statement recognizing May 28 to June 3, 2017, as Tourism Week in Canada, and regarding Alberta's reputation as a world-class tourist destination and a \$100,000 grant from the Government of Alberta to the Aboriginal Tourism Association of Canada.

Mr. Yao, Hon. Member for Fort McMurray-Wood Buffalo, made a statement recognizing Dave Kirschner, who passed away on May 28, 2017, for his many years of charitable work in Fort McMurray, and regarding the planned Willow Square continuing care facility in Fort McMurray which is still not built.

Presenting Petitions

Mr. Nielsen, Hon. Member for Edmonton-Decore, presented a petition from 98 Albertans urging the Government to introduce legislation to amend the Labour Relations Code to prohibit the practice of double-breasting whereby a unionized corporation is permitted to operate a non-unionized subsidiary as a means of undermining a collective agreement.

Mr. Nielsen, Hon. Member for Edmonton-Decore, presented a petition from 117 Albertans urging the Government to do the following: 1) construct a memorial on public land adjacent to Highway 63 near Fort McMurray to honour the skilled trade workers who have been injured or killed while working on oil sands projects and to commemorate the 50th anniversary of the production of the first barrel of oil from Alberta's oil sands on September 30, 2017; and 2) introduce legislation to recognize May 1 in Alberta as an annual statutory holiday known as International Workers' Day.

Mr. Nielsen, Hon. Member for Edmonton-Decore, presented a petition from 99 Albertans urging the Government to introduce legislation to accomplish the following: 1) repeal sections 34(1)(e) and 38(2) of the Labour Relations Code, to remove the prohibition on certifying a trade union as a bargaining agent when engaged in certain types of picketing; 2) end the practice of grouping trade unions by repealing section 172 of the Labour Relations Code, and making any necessary consequential amendments to the legislation; and 3) repeal amendments to the Labour Relations Code contained in the Labour Relations Amendment Act, 2008.

Mr. Cooper, Hon. Member for Olds-Didsbury-Three Hills, requested and received the unanimous consent of the Assembly to call it 5:00 p.m. and begin consideration of Motions Other Than Government Motions.

Motions Other Than Government Motions

507. Moved by Mr. Fraser:

Be it resolved that the Legislative Assembly urge the Government to establish a special committee to review accessibility legislation and consider potential amendments to legislation, including but not limited to the Safety Codes Act and the Elevating Devices Codes Regulation, Alta. Reg. 192/2015, with the intent to ensure accessibility for Albertans that exceeds the base requirements of the Alberta Building Code 2014.

A debate followed.

The Speaker intervened to advise the Assembly that there was a discrepancy between the wording of the motion on the Order Paper and how it was worded on the original motion signed by Mr. Fraser.

Mr. Fraser clarified the wording he wished to use and then requested and received the unanimous consent of the Assembly to proceed with the wording of the motion as it appeared on the Order Paper.

The Speaker then stated that the time used with respect to this correction will not be counted in the debate time.

Ms Renaud, Hon. Member for St. Albert, moved that the motion be amended as follows:

- (a) by striking out "consider" and substituting "conduct a thorough consultation regarding"; and
- (b) by striking out all of the words that follow "Albertans".

A debate followed on the amendment.

The question being put, the amendment was agreed to.

Bill 16 An Act to Cap Regulated Electricity Rates (\$) — Hon. Ms McCuaig-Boyd

Mr. Panda, Hon. Member for Calgary-Foothills, moved that the Bill be amended as follows:

A. The following is added after section 2:

Economic impact assessment

2.1(1) One month after the date on which this Act receives Royal Assent, the Minister shall prepare a projection of the economic impact of the imposition of maximum rates established in section 2 on electricity consumers who are not regulated rate customers.

(2) The Minister shall lay a copy of the projection prepared under subsection (1) as soon as practicable before the Assembly if it is then sitting or, if it is not sitting, within 15 days after the commencement of the next sitting.

B. Section 8 is struck out and the following is substituted:

Coming into force

8 Sections 2(2), 3 and 6(1)(c) and (d)(iii) come into force on the later of the following:

- (a) January 1, 2018;
- (b) 30 days after the date on which the Minister lays the projection prepared under section 2.1(2) before the Assembly.
