## **ROUTINE**

### **Members' Statements**

Mrs. Littlewood, Hon. Member for Fort Saskatchewan-Vegreville, made a statement regarding the Josephburg Agricultural Society and their work to make life in rural Alberta better by promoting several events.

Mr. Barnes, Hon. Member for Cypress-Medicine Hat, made a statement regarding the value of energy workers and engineers, who are struggling with unemployment due to Government policies and are the target of unfair attacks by radical environmental groups.

Mr. Ellis, Hon. Member for Calgary-West, made a statement regarding the need for the Government to address several concerns of Calgary residents living near the Calgary southwest ring road construction route.

Mr. Piquette, Hon. Member for Athabasca-Sturgeon-Redwater, made a statement regarding Alberta Culture Days, to be held from September 29 to October 1, 2017, and urging local organizations to apply to Alberta Culture and Tourism for grant funding for this event.

Ms Goehring, Hon. Member for Edmonton-Castle Downs, made a statement regarding 15 students from the Edmonton Islamic Academy who participated in the National High School Model United Nations Conference, held in New York City, New York, from March 9 to 13, 2017, and thanking their families and school staff for their support.

Mr. Panda, Hon. Member for Calgary-Foothills, made a statement regarding how the downturn in the economy is affecting energy sector engineers and technologists who are waiting for new Government training programs.

## **Presenting Petitions**

Mr. Ellis, Hon. Member for Calgary-West, presented a petition from 724 Calgary residents urging the Government to:

1. Implement and apply the City of Calgary's noise policy; that is a 65 dBA requirement during peak traffic hours and not base it on a 24 hour average. We request that all sound attenuation requirements meet the City of Calgary guidelines in this situation, since the area is within the city limits and is the narrowest portion of the entire ring road/TUC right-of-way;
2. Commit to a sound monitoring protocol with our community representatives, and consult our community on the design and construction/installation engineered acoustic berms, sound walls and/or other equivalents that will meet the City of Calgary noise attenuation requirements;
3. Integrate into the on and off ramp design physical protection or equivalent measures to mitigate vehicles from leaving the roadway and entering private property; and
4. Replace and replant as many trees as possible, as trees are an important natural barrier to help dampen sound and mitigate pollution emissions and provide the residents with a modest level of health protection and aesthetic relief.
