**34.** Oral notice having been given November 27, 2017, moved by Hon. Mr. Bilous on behalf of Hon. Mr. Mason:

Be it resolved that, pursuant to Section 11(1) of the Electoral Boundaries Commission Act, the Legislative Assembly concur in the recommendations of the Final Report of the Alberta Electoral Boundaries Commission entitled "Proposed Electoral Division Areas, Boundaries, and Names for Alberta, Final Report to the Speaker of the Legislative Assembly of Alberta, October 2017," which was tabled by the Speaker of the Legislative Assembly as an Intersessional Deposit on October 19, 2017 (Sessional Paper 456/2017).

A debate followed.

Mr. Nixon, Hon. Leader of the Official Opposition, moved that the motion be amended by adding the following after "(Sessional Paper 456/2017)":

except that the name of the proposed electoral division of Rocky Mountain House-Sundre be changed to Rimbey-Rocky Mountain House-Sundre, Athabasca-Barrhead be changed to Athabasca-Barrhead-Westlock, Cold Lake-St. Paul be changed to Bonnyville-Cold Lake-St. Paul, and Okotoks-Sheep River be changed to Highwood;

And be it further resolved that the Assembly direct the Chief Electoral Officer to revise the DVD tabled by the Speaker on November 27, 2017 (Sessional Paper 586/2017) by incorporating the amendments to this motion, and to transmit the revised DVD forthwith to the Speaker for tabling in the Assembly.
