# **VOTES AND PROCEEDINGS**

Monday, March 19, 2018

The Speaker took the Chair at 1:30 p.m.

The Speaker offered a prayer, and a moment of silence was observed in recognition of the death of former Member Mrs. Mary Jean LeMessurier, Member for Edmonton-Centre, 1979 to 1986, who passed away on March 11, 2018.

#### **Members' Statements**

MLA Connolly, Hon. Member for Calgary-Hawkwood, made a statement regarding the 20th anniversary of the Supreme Court of Canada's Vriend decision and the Hon. Leader of the Official Opposition's stance on LGBTQ2S rights at the time of the decision.

Mr. Loewen, Hon. Member for Grande Prairie-Smoky, made a statement regarding how the Government's ideology leads to policies that do not support Alberta in light of several federal government initiatives, including the federal government's caribou range plans.

Mr. Orr, Hon. Member for Lacombe-Ponoka, made a statement regarding how the Government's social and criminal justice policies have led to innocent citizens in rural Alberta being preyed upon by criminals.

Ms Goehring, Hon. Member for Edmonton-Castle Downs, made a statement regarding the Lorelei Beaumaris Community League, its wide range of programming, and a recent Community Facility Enhancement Program grant it received from the Government.

Mr. Piquette, Hon. Member for Athabasca-Sturgeon-Redwater, made a statement regarding steps taken by the Government to combat crime and expressing disappointment in the United Conservative Party's fiscal priorities concerning rural crime prevention.

Mr. McIver, Hon. Member for Calgary-Hays, made a statement regarding the failure of the Government's provincial carbon levy, which has contributed to investment moving to other parts of the world and will therefore increase greenhouse gas emissions.

## **Presenting Petitions**

Hon. Mr. Kenney, Hon. Leader of the Official Opposition, presented a petition from approximately 8,000 Albertans urging the Government that before caribou range plans are adopted and submitted to the Federal Government for the northwest region of Alberta, a complete and full socio-economic assessment for the region is completed that includes financial, recreational, and traditional impacts to communities, businesses, and citizens as it relates to caribou range planning, and further urging the Alberta Government to forgo any type of additional permanent conservation land designation in lieu of strategies that are focused on population recovery and include a multi-species approach.
