# **Ministerial Statements**

Hon. Ms Notley, Premier, made a statement regarding the tragic deaths of 15 members of the Humboldt Broncos hockey club in a highway collision in rural Saskatchewan on April 6, 2018

Hon. Mr. Kenney, Hon. Leader of the Official Opposition, commented on the statement.

Hon. Mr. Mason, Government House Leader, requested and received the unanimous consent of the Assembly to allow a Member from the Alberta Party caucus to comment on the Ministerial Statement.

Mr. Fraser, Hon. Member for Calgary-South East, then commented on the statement.

Hon. Mr. Mason, Government House Leader, requested and received the unanimous consent of the Assembly to allow the Hon. Member for Calgary-Mountain View and the Hon. Member for Vermilion-Lloydminster to comment on the Ministerial Statement.

Dr. Swann, Hon. Member for Calgary-Mountain View, and Dr. Starke, Hon. Member for Vermilion-Lloydminster, then commented on the statement.

### **Members' Statements**

Ms Goehring, Hon. Member for Edmonton-Castle Downs, made a statement recognizing April 9, 2018, as the 101st anniversary of the Battle of Vimy Ridge, and regarding Roberta MacAdams, one of 45,000 Albertans to serve in World War I and who was one of the first two women elected as a Member of the Legislative Assembly of Alberta.

Mr. van Dijken, Hon. Member for Barrhead-Morinville-Westlock, made a statement recognizing April 9, 2018, as Vimy Ridge Day, regarding the need for resilience in the face of adversity, and thanking those who pass on this value, particularly veterans.

Hon. Mr. Mason, Government House Leader, requested and received the unanimous consent of the Assembly to waive Standing Order 7(7) in order to complete the Daily Routine.

Mr. Hinkley, Hon. Member for Wetaskiwin-Camrose, made a statement regarding a course on the Truth and Reconciliation Commission offered by the University of Alberta's Augustana Campus in Camrose, and regarding Government actions to implement the Commission's calls to action.

Mr. Yao, Hon. Member for Fort McMurray-Wood Buffalo, made a statement thanking the Rotary District 5370 Charitable Foundation and its donors for several fundraising projects that helped Fort McMurray recover from the 2016 wildfires.

Mrs. Littlewood, Hon. Member for Fort Saskatchewan-Vegreville, made a statement recognizing April 13, 2018, as the 100th year of the United Farmers of Alberta and regarding the importance of cooperatives and economic democracy.

Mr. Cooper, Hon. Member for Olds-Didsbury-Three Hills, made a statement regarding the selfless life and legacy of Darcy Haugan, coach of the Humboldt Broncos, who passed away with 14 other team members in a highway collision on April 6, 2018.
