The Speaker took the Chair at 1:30 p.m.

The Speaker offered a prayer, and a moment of silence was observed in recognition of the deaths of former Member Mr. Thomas William Chambers, Member for Edmonton-Calder from 1971 to 1986, who passed away on June 23, 2018; Gordon Munk, Assistant Sergeant-at-Arms of the Legislative Assembly from 2009 to 2016, who passed away on July 26, 2018; and Jacqueline Marie Breault, Manager of Corporate Services and Senior Records Officer for the Legislative Assembly Office, who passed away on September 7, 2018.

Introduction of New Member

The Speaker invited Hon. Mr. Kenney, Hon. Leader of the Official Opposition, to proceed to the main doors of the Chamber and escort Ms Goodridge into the Chamber.

The Speaker announced that he had received from the Chief Electoral Officer of Alberta the report of the Returning Officer for the constituency of Fort McMurray-Conklin containing the results of the by-election conducted on July 12, 2018, which states that a by-election was conducted in the constituency of Fort McMurray-Conklin and that Ms Laila Goodridge was duly elected as the Member for Fort McMurray-Conklin.

Ms Goodridge joined Hon. Mr. Kenney and was escorted to the Mace. Hon. Mr. Kenney presented Ms Goodridge to the Speaker and the Hon. Member for Fort McMurray-Conklin took her seat in the Assembly.

The Speaker then invited Hon. Mr. Kenney, Hon. Leader of the Official Opposition, to proceed to the main doors of the Chamber and escort Mr. Dreeshen into the Chamber.

The Speaker announced that he had received from the Chief Electoral Officer of Alberta the report of the Returning Officer for the constituency of Innisfail-Sylvan Lake containing the results of the by-election conducted on July 12, 2018, which states that a by-election was conducted in the constituency of Innisfail-Sylvan Lake and that Mr. Devin Dreeshen was duly elected as the Member for Innisfail-Sylvan Lake.

Mr. Dreeshen joined Hon. Mr. Kenney and was escorted to the Mace. Hon. Mr. Kenney presented Mr. Dreeshen to the Speaker and the Hon. Member for Innisfail-Sylvan Lake took his seat in the Assembly.

Hon. Mr. Mason, Government House Leader, requested and received the unanimous consent of the Assembly to waive Standing Order 7(1.1) in order to complete Ministerial Statements.

Ministerial Statements

Hon. Min. Miranda, Minister of Culture and Tourism, made a statement regarding the shooting at the Tree of Life synagogue in Pittsburgh, Pennsylvania, on Saturday, October 27, 2018, that killed 11 people, and a moment of silence and traditional Jewish prayer were observed for the victims.

Hon. Mr. Kenney, Hon. Leader of the Official Opposition, commented on the statement.

Hon. Mr. Mason, Government House Leader, requested and received the unanimous consent of the Assembly to allow the Hon. Member for Calgary-Elbow to comment on the Ministerial Statement.

Mr. Clark, Hon. Member for Calgary-Elbow, then commented on the statement.

Pursuant to Standing Order 7(8), Hon. Mr. Mason, Government House Leader, provided notice to the Assembly that the Daily Routine shall continue beyond 3:00 p.m.

Speaker's Statement – Oral Question Period and Members' Statements Rotations.

Honourable Members, before we proceed to Oral Question Period, I would like to inform all Honourable Members about changes to both the Oral Question Period and Members' Statements rotations.

My office received a signed House Leaders' Agreement on October 24, 2018. After reviewing the document and the changes proposed in it, I have decided to accept it. I have noted the agreement and the rotations in the memorandum that I sent to all Members on October 26, 2018.

The changes to the Oral Question Period rotation indicated in the agreement, as compared to the rotation used during the Spring Sitting of the Fourth Session of the 29th Legislature, are as follows.

The Member for Calgary-Greenway may ask question six on days three and seven of the eight-day rotation. These questions were previously allocated to the Official Opposition.

The House Leaders' Agreement has also added a question 17 to the rotation. This question has been evenly allocated between the Official Opposition and Government caucuses, with each caucus receiving four questions total on alternating days, starting on day one with the Official Opposition.

Turning to the Members' Statements rotation, the House Leaders' Agreement stipulates that the Member for Calgary-Greenway receives one Member's Statement every three weeks on a Thursday, starting on November 8, 2018.

I have asked that copies of both the Oral Question Period rotation and the Projected Sitting Days Calendar, which contains the Members' Statements rotation, among other things, be placed on Members' desks. Please consult these documents for further information about the rotations.

Also note that as the Assembly commences the Fall Sitting today, Members are on day eight of the Oral Question Period rotation and week two of the Members' Statements rotation.
