Second Reading

On the motion that the following Bill be now read a Second time:

Bill 8 Education Amendment Act, 2019 — Hon. Min. LaGrange

Debate continued on the amendment introduced by Mr. Nielsen, Hon. Member for Edmonton-Decore, on behalf of Mr. Eggen, Hon. Member for Edmonton-North West, on June 24, 2019, that the motion be amended by deleting all of the words after "that" and substituting the following:

Bill 8, Education Amendment Act, 2019, be not now read a Second time but that the subject matter of the Bill be referred to the Standing Committee on Families and Communities in accordance with Standing Order 74.2.

Hon. Mr. Nixon, Government House Leader, requested the unanimous consent of the Assembly to shorten the interval between division bells to one minute for the remainder of the evening, including the duration of Committee of the Whole consideration.

Unanimous consent was not granted.

Debate continued on the amendment.

Hon. Mr. Nixon, Government House Leader, requested and received the unanimous consent of the Assembly to waive Standing Order 32(2) and (3) in order to shorten the interval between division bells to one minute for the remainder of the evening, including the duration of Committee of the Whole consideration.

Bill 8 Education Amendment Act, 2019 — Hon. Min. LaGrange

Ms Pancholi, Hon. Member for Edmonton-Whitemud, moved that the Bill be amended by striking out section 10 and substituting the following:

- 10 Section 33 in amended
 - (a) in subsection (1)(e) by striking out "specialized";
 - (b) by adding the following after subsection (2):
 - (2.1) A policy established under subsection (2) must contain a distinct portion that addresses the board's responsibilities under section 35.1, and the distinct portion of the policy
 - (a) must provide that a principal is responsible for ensuring that notification, if any, respecting a voluntary student organization or an activity referred to in section 35.1(1)
 - (i) is limited to the fact of the establishment of the organization or the holding of the activity, and
 - (ii) is otherwise consistent with the usual practices relating to notifications of other student organizations and activities,

and

- (b) must provide that a principal is required to
 - (i) immediately grant permission to establish a voluntary student organization or hold an activity at the school under section 35.1(1)(a), and
 - (ii) designate a staff member to serve as a staff liaison under section 35.1(1)(b) within a reasonable amount of time after receiving a request to establish a voluntary student organization or to assist in the organizing of an activity, subject to section 35.1(4).
