## **Speaker's Statement – 75th Anniversary of VE Day**

The Speaker made a statement recognizing May 8, 2020, as the 75th anniversary of Victory in Europe Day and recognizing the sacrifices made by service members in defence of Canada.

#### **Notices of Motions**

Hon. Mr. Nixon, Government House Leader, gave oral notice of the following motion:

- 20. Be it resolved that the Legislative Assembly
  - (a) recognize that the criminal use of firearms primarily involves unlicensed individuals, often using illegally smuggled firearms;
  - (b) express its opposition to the Government of Canada's recent decision to amend regulations to the Criminal Code to prohibit the possession, transportation and sale of certain types of legally-acquired firearms by licensed, law-abiding citizens; and
  - (c) urge the Government of Alberta to take all necessary steps to assert provincial jurisdiction in connection with these matters, including replacing the Chief Firearms Officer having jurisdiction for Alberta as designated by the federal Minister of Public Safety and Emergency Preparedness with a chief firearms officer for Alberta designated by the Government of Alberta in accordance with the Firearms Act (Canada).

#### Committee of the Whole

Bill 14 Utility Payment Deferral Program Act — Hon. Mr. Nally

Mr. Sabir, Hon. Member for Calgary-McCall, moved that the Bill be amended as follows:

- (a) section 1 is amended
  - (i) in clause (b) by striking out "June 18, 2020" and substituting "March 18, 2021, or as otherwise prescribed in the regulations",
  - (ii) in clause (d) by striking out "June 19, 2021 and ending on June 18, 2022" and substituting "March 19, 2022 and ending March 18, 2023, or as otherwise prescribed in the regulations", and
  - (iii) in clause (e) by striking out "June 19, 2020 and ending June 18, 2021" and substituting "March 19, 2021 and ending on March 18, 2022, or as otherwise prescribed in the regulations";
- (b) section 6(2) is amended by striking out "June 18, 2021" and substituting "the day the repayment period ends";
- (c) section 11 is amended
  - (i) in subsection (1) by striking out "June 19, 2021" and substituting "the day the rate rider period begins",
  - (ii) in subsection (2)(a) by striking out "June 18, 2021" and substituting "the day the repayment period ends", and
  - (iii) in subsection (3) by striking out "June 18, 2021" and substituting "on the day the repayment period ends";
- (d) section 16(2) is amended by striking "June 18, 2021" and substituting "the day the repayment period ends";
- (e) section 21 is amended
  - (i) in subsection (1) by striking out "June 19, 2021" and substituting "the day the rate rider period begins", and
  - (ii) in subsection (2)
    - (A) in clause (a)(i) by striking out "June 18, 2021" and substituting "the day the repayment period ends", and
    - (B) in clause (b) by striking out "June 18, 2021" and substituting "the day the repayment period ends";
- (f) section 29 is amended by adding the following immediately after clause (a):
  - (a.1) prescribing
    - (i) the end date of the period referred to in section 1(b), no earlier than March 18, 2021

- (ii) the start and end dates of the period referred to in section 1(d), with the start date of the period no earlier than the day after the end of the repayment period and the end date of the period no earlier than March 18, 2023, and
- (iii) the start and end dates of the period referred to in section 1(e), with the start date of the period no earlier than the day after the end of the deferral period and the end date of the period no earlier than March 18, 2022;
- (g) section 33 is amended by striking out "June 18, 2023" and substituting "March 18, 2024, unless it is continued for a further period by an order of the Lieutenant Governor in Council".

Mr. Sabir, Hon. Member for Calgary-McCall, moved that the Bill be amended as follows:

- (a) section 7 is amended by striking out subsection (2) and substituting the following:
  - (2) A deferral account approved by the Commission under subsection (1) must use the weighted average cost of capital to determine the carrying costs that may be collected in respect of the deferred payments, excluding the cost of interest.
- (b) section 11 is amended by adding the following immediately after subsection (6):
  - (7) The Commission may not approve a rate rider under subsection (2) that includes the cost of interest.
- (c) section 17 is amended by striking out subsection (4) and substituting the following:

- (4) A deferral account approved by the Commission under this section must use the weighted average cost of capital to determine the carrying costs that may be collected in respect of the deferent payments, excluding the cost of interest.
- (d) section 21 is amended
  - in subsection (2) by adding ", subject to subsection (5)," immediately after "transmission providers and gas distributors, and", and
  - (ii) by adding the following immediately after subsection (4):
    - (5) The Commission may not initiate a proceeding to establish a rate rider under subsection (2) that includes the cost of interest.
