Presenting Petitions

Mr. Schmidt, Hon. Member for Edmonton-Gold Bar, presented a petition from over 1,500 Albertans urging the Government to (1) halt the removal of any provincial parks, recreation areas and natural areas from Alberta's parks system or any of the associated closures, sales or transfers of infrastructure at these areas to third-party managers, as announced by the Alberta Government on March 3, 2020; (2) keep Chain Lakes, Lawrence Lake, and Fawcett Lake Provincial Recreation Areas fully open within the parks system; (3) keep Alberta's parks publicly managed, open, and protected under the Provincial Parks Act so that recreation areas are available for everyone to enjoy and appreciate nature, thereby enhancing health and well-being, and honouring the ancestors who cared enough to preserve these beautiful natural areas for future generations; and (4) disclose parks usage data, relevant wildlife and water studies, projected impacts on tourism, etc in any future public consultations on Alberta parks management.
