The following Bill was taken under consideration:

Bill 15 Education (Reforming Teacher Profession Discipline) Amendment Act, 2022

Ms Hoffman, Hon. Member for Edmonton-Glenora, moved that the Bill be amended in section 12 as follows:

- (a) in the proposed section 225.8
 - (i) in subsection (2), by striking out "The Minister may appoint" and substituting "Subject to subsection (2. 1), the Minister may appoint", and
 - (ii) by adding the following immediately after subsection (2):
 - (2.1) At least half of the panel members appointed under subsection (2) must be recommended by The Alberta Teacher's Association.
- (b) in the proposed section 225.9
 - (i) in subsection (1)(b) by striking out "in accordance with the regulations" and substituting "in accordance with subsection (2.1) and the regulations",
 - (ii) in subsection (2)(a) by striking out "in accordance with the regulations" and substituting "in accordance with subsection (2.1) and the regulations", and
 - (iii) by adding the following immediately after subsection (2):
 - (2.1) At least half of the committee members appointed under subsections (1)(b) or (2)(a) must be panel members appointed in accordance with section 225.8(2.1).
