Motions Other Than Government Motions

516. Moved by Mr. Long:

Be it resolved that the Legislative Assembly urge the Government to consider taking the necessary steps to develop an auxiliary workforce program for local residents, volunteer associations, and landowners to supplement the work of first responders during emergencies and disasters.

A debate followed.

Ms Sweet, Hon. Member for Edmonton-Manning, on behalf of Ms Wright, Hon. Member for Edmonton-Beverly-Clareview, moved that the motion be amended by striking out “first responders during emergencies and disasters” and substituting “provincially-regulated first responders during emergencies and disasters, and by using certified training programs provided by the Royal Canadian Mounted Police, firefighters, paramedics, First Nations and Métis settlements”.
