Ms Pancholi, Hon. Member for Edmonton-Whitemud, moved that the Bill be amended in section 12 as follows:

- (a) in the proposed section 58.11 as follows:
  - (i) in subsection (1) by striking out "provide notice to, and seek the consent of" and substituting "provide notice to and, if required by the policies, seek the consent of";
  - (ii) in subsection (3) by striking out "provided consent for the student to do so in accordance with the policies established under section 58.12" and substituting "been notified under subsections (1) and (2) and, if the board's policies established under section 58.12 require the parent's consent, provided that consent in accordance with those policies";

- (iii) in subsection (4) by striking out "Where no consent has been provided under this section in respect of a student" and substituting "If a parent's consent is required under this section in respect of a student and that consent is not provided, or if a parent's consent is not required in respect of a student and the parent makes a signed written request that the student be excluded from all or part of the instruction, course or program of study or use of instructional materials";
- (b) in the proposed section 58.12 as follows:
  - (i) in subsection (1) by striking out "the provision of notice to, and the seeking the consent of" and substituting "the provision of notice to, the seeking of consent of, the provision of consent by, and the making of a request by";
  - (ii) in subsection (2)(a) as follows:
    - (A) by striking out subclause (i) and substituting the following:
      - (i) the form and manner of the provision of notice under section 58.11(1), which must include sufficient detail to enable the parent to make an informed decision in respect of providing consent under section 58.11(3) or making a request under section 58.11(4);
    - (B) in subclause (ii) by striking out "section 58.11(2)" and substituting "sections 58.11(1) and (2)";
    - (C) by adding the following immediately after subclause (ii):
      - (ii.1) whether the board is required to seek a parent's consent under section 58.11(1);
    - (D) by striking out subclause (iii) and substituting the following:
      - (iii) if the policies require the board to seek the consent of the parent of a student, the form and manner of that consent, which must provide the parent with the option to provide consent for the student to take part in all or part of a course or program of study, or use all or part of instructional materials or an exercise, referred to in section 58.11;
      - (iii.1) the form and manner in which a parent of a student may submit a request under section 58.11(4) for the student to be excluded from the instruction, course or program of study or use of instructional materials;

Hon. Mr. Nicolaides, Minister of Education, moved that the Bill be amended as follows:

- A Section 7 is amended in the proposed section 18.1
  - (a) in subsection (2) by striking out "A board" and substituting "Subject to subsection (3.1), a board";
  - (b) by adding the following after subsection (3):
    - (3.1) Subsection (2) does not apply where the learning and teaching resources are used or provided to provide religious instruction.
    - (3.2) Where the use or provision under subsection (3.1) is by an external party, a board shall not permit that use or provision unless the external party is approved by the Minister.
- B Section 9 is amended in the proposed section 33.2

- (a) by striking out subsection (2) and substituting the following:
  - (2) Subject to subsection (4), if a student requests that a new preferred name or pronouns be used by teachers, teacher leaders and other school staff when referring to the student in school, the board shall notify the student's parent of the request.
- (b) in subsection (3)
  - (i) by striking out "in school" and substituting "in school,";
  - (ii) by striking out clauses (a) and (b) and substituting the following:
    - (a) in the case of a student who is 16 or 17 years of age, until the student's parent is notified under subsection (2), or
    - (b) in the case of a student who is under 16 years of age,
      - (i) until the student's parent is notified under subsection (2), and
      - (ii) unless the parent provides consent for the new preferred name or pronouns to be used by teachers, teacher leaders and other school staff when referring to the student in school.
    - (c) in subsection (4)(a) by striking out "or seeking the parent's consent".
